Fee Deadlines:

The preview fee is due before makeup application starts. We regret that we cannot accept credit cards – check or cash only.

A deposit of 40% is due at the time of the trial, or must be postmarked within 3 days after preview to avoid a \$20 late fee. With late deposits, loss of reservation may occur, should another party inquire about the same date.

The balance is due 20 days prior to wedding date -or- in cash on day of wedding.

Please note that the bride is responsible for the entire contracted amount, even if other individuals are paying for their own services. The fee is due to the makeup artist as described, regardless of internal arrangements between bride and others receiving services.

Cancellations - The client has 72 hours to cancel the contract and receive the deposit in return; after this period it is non-refundable. At 20 days prior to the wedding, the entire contract is committed and will be due also in the event of a last minute cancellation.

Wedding Day Logistics:

- Makeup/Hair services can only be done if an individual is in the makeup/styling chair at the agreed upon time. The makeup artist will give the bride a detailed schedule ahead of time. The bride is responsible for communicating to everyone the importance of being on time and properly prepared (i.e. clean face, brushed teeth, etc.).
- The bride is responsible for having the location ready for the artist/stylist at the agreed upon time. The artist/stylist will need space for her chair and a table with satisfactory room in an area in front of window with ample natural lighting, outlet access, no walk-through traffic and normal room temperature. Stylist will need chair for style station.
- Please keep all children and pets far away from the makeup/hair station.

The makeup artist/hair stylist commits that the agreed-upon time frame will be reserved for your wedding, provided fees are paid in accordance with this contract.

Should she have a personal emergency that precludes the artist/stylist from performing services as agreed, all necessary efforts will be made so that another artist/stylist of high quality will be present to perform the contracted services, and a 15% refund of all services for makeup or hair will apply. If no artist/stylist can be made available, all fees for makeup or hair (including preview) will be refunded. Policy applies only to services in conflict with said artist or stylist (i.e. hair or makeup).
